DRESSING ROOMS AND SHOWERS: Dressing rooms and showers will be available at the Civic Center for the entire tournament.

PARKING: LOT A (west lot) will be used as the drop-off and parking area. The quickest way to get to LOT A is to go to 5th Street just west of the Exhibition Hall. Participants will have an area in the Exhibition Hall to lounge (camp out) and warm-up. A curtained area in the Exhibition Hall will be used for weigh-ins. Wrestlers, student managers/trainers, cheerleaders and coaches must enter the Rotary through Door E-42.

WEIGH-INS:

A. Weigh-ins will start at: 8:30 a.m. on Friday and at 8:00 a.m. on Saturday. **DOORS WILL BE LOCKED AT THE START OF WEIGH-INS. TEAMS MUST BE ON TIME.**

B. Weigh-ins will be conducted in weight class order. Challenges to be made immediately.

SEEDING MEETING: The seeding meeting will be held on Thursday, January 4 at 7:00 p.m. in the Hughes Administration Building (806 North Washington). PLEASE ENTER THROUGH THE WEST DOORS. GO UP THE WEST RAMP. The seeding committee is open to all head coaches. The top 8 wrestlers will be seeded and a 9th alternate will be designated in each weight class. Non seeded wrestlers will be placed into their brackets randomly. THE GRIEVANCE COMMITTEE WILL NOT REVIEW ANY GRIEVANCE REGARDING SEEDING. PLACEMENT AT THE SEEDING MEETING IS FINAL.

FIRST MATCH OF EACH ROUND: By a random draw it is determined that each round of wrestling will begin with the 152 lb. weight class.
